President's Message: Setting the Record Straight on Turbines

This month has certainly provided an "interesting" start for the new board. I want to take a moment to address some rumors circulating regarding turbine aircraft at our field. Transparency is a priority for this board, so here are the facts:

The Turbine Demonstration Event

The board recently voted 7-2 to approve a **one-time special demonstration event**. This is not a change in club flight privileges. We have invited two professional pilots—both fully AMA-certified in turbine helicopter safety—to perform a demonstration. Our event coordinator has worked diligently to ensure this event meets every safety requirement set by both the Palomar RC Flyers and the Academy of Model Aeronautics (AMA).

To ensure we considered all angles, the current board consulted with several past presidents before moving forward with this limited engagement.

Our Long-Term Policy: We Are a No-Turbine Field

I want to be incredibly clear: **The board has not approved turbines for general membership or guest use.** At this month's meeting, the board will be drafting specific language for our bylaws to officially exclude all turbine flight for members and guests.

We may include a provision allowing the board to approve future special events (limited strictly to helicopters), but the day-to-day operations of our field will remain turbine-free.

The Membership Has the Final Say

As with any significant change to our Club Bylaws, the board's proposed language must be **approved by you, the membership**. You are the final decision-makers on how our field is governed.

We value the culture of our field and are committed to maintaining the standards you expect. I look forward to seeing you at the next meeting to discuss this further.

Altitude Quest Winners on January 10, 2026

On Saturday, January 10, the Altitude Quest Contest was held at Johnson Field. The pilots included Don Davis, John Forestrieri, Bob Hague. Doug Abel;, Mark Anderson, Allan Graber, Scott McClintock, Chuck Riley, Joe Buko, and Randy Brunette

Altitude Quest is a game where a random elevation is assigned to each pilot and a small altimeter is attached to the pilot’s aircraft. The pilots are then required to fly their aircraft as close as they can to the assigned elevation.

In first place was President Don Davis, second was John Forestrieri, and third was Bob Hague. The payouts were \$25, \$15, and \$10 respectively. John generously donated his prize money to the club.

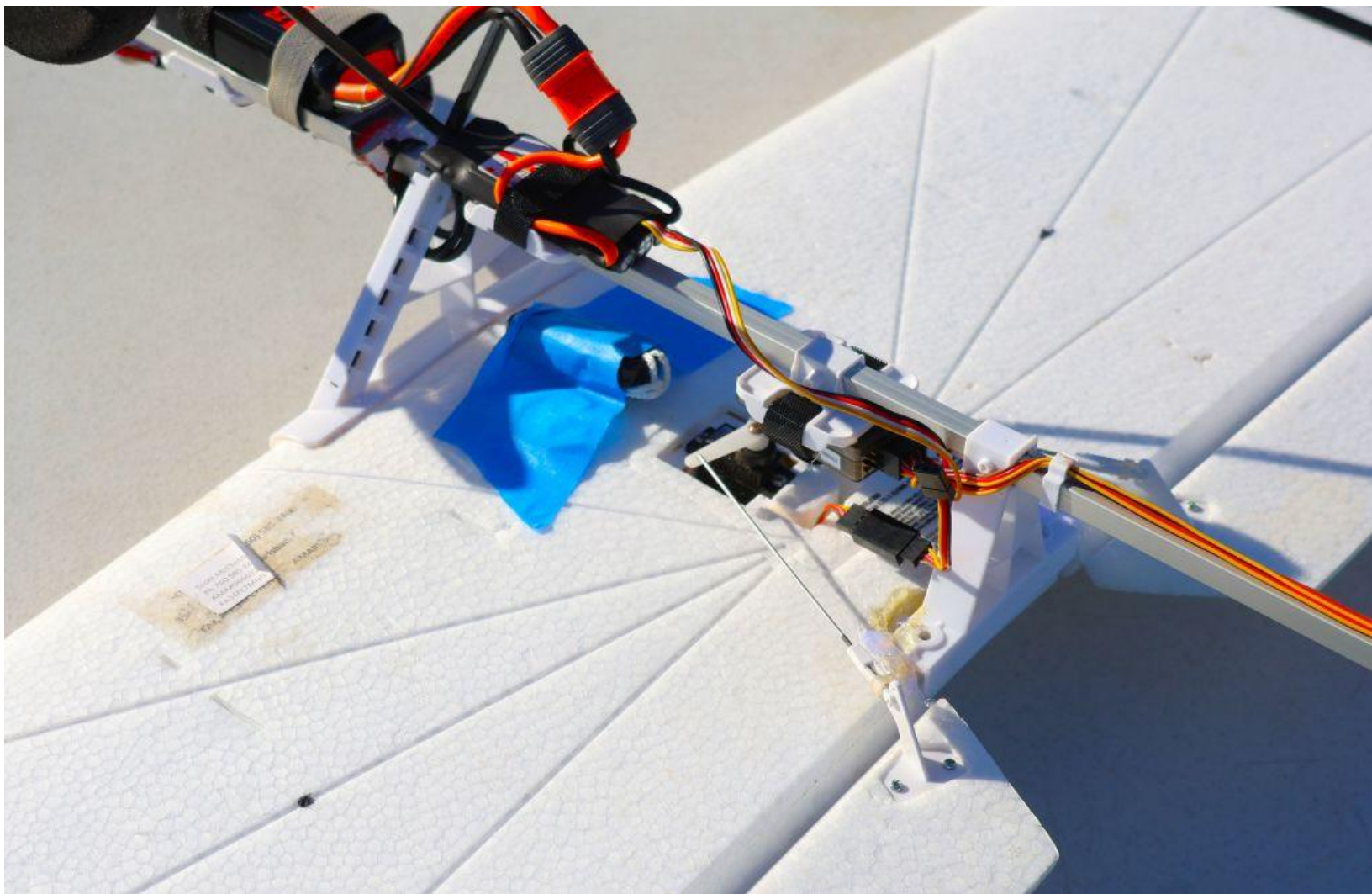
Each pilot spun this dial to determine the altitude to which he was to fly.

1/5/26 Board Meeting:

6:30 - Role Call. Motion to approve previous meeting minutes approved.

6:31 - Treasury report by Tom Pollinger:

Income: \$13,872

Expenses: \$4,932

Net Income: \$8,940

Balance: \$65,319

6:36 - Mark Olsen on Fight Training – Been quiet with the holidays, but still going well!

6:38 - Mark Olsen on safety - No significant safety matters over the last month.

6:40 – Don Davis introduced the new Board members: Tom Pollinger, Mark Anderson, and Ron Holman. We found out that all the new Board members have or had pilot's licenses – what a great perspective these three will bring to the Board! Tom is a commercial pilot for SkyWest, which is very cool – discounts for members, Tom?

6:45 – Eric Armstrong provided an update on the upcoming Heli Fun Fly. Eric put a motion forward to approve him inviting two turbine pilots to the Heli Fun Fly. Mark Olsen seconded the motion.

6:50 – Don Davis opened up the conversation around Eric Armstrong’s request to invite two turbine heli pilots to all in attendance. Eric presented his safety plan to the attendees and addressed questions and concerns from all parties. The past presidents were divided on the matter, with half supporting the idea and half not. One past president brought up issues that had not been previously considered. 1) Johnson Field operating inside a “Mode C Veil”. 2) A new San Diego County law titled “Zone 0 Law”, and 3) A letter from CalFire dated back to 2004 stating no turbines were allowed at Johnson Field. The letter was not in anyone’s possession. The member had contacted CalFire but did not receive a response. No supporting documentation was provided relating to the Mode C Veil and Zone 0 Law.

From the information stated, Eric Armstrong withdrew his request to invite two turbine heli pilots until the board was provided with more information about Mode C and the Zone 0 law.

7:50 – Chuck Riley made a motion to approve an expense of \$750 for tractor maintenance and the purchase of a grading tool that would be attachable to our tractor.

Brandon Liesemeyer seconded the motion. Motion approved with 8 Yes votes and 0 No votes.

7:57 - Board meeting adjourned.

1/5/26 Follow-Up Board Meeting:

6:30 – Eric Armstrong presented his findings relating to our Mode C Veil and San Diego County’s Zone Law:

The “Zone Zero Law”

Eric called the San Diego City Council’s office, spoke with the Chief Community Services Officer and City Engineer. She stated that Zone Zero does not apply to our application.

The “Mode C Veil” possibly requiring clearance to fly turbines

Eric spoke to the FAA representative who covers the flight regulations for our region, including Mode C veil requirements. His name is Paul Hamilton. Paul said we do operate under a Mode C Veil, which is an FAA term. He also confirmed there are no restrictions on unmanned aircraft operating under a Mode C Veil, provided the location is at a “fixed, AMA sanctioned location”. Eric asked what he meant by fixed. Paul said it means you have a permanent location.

Eric spoke directly to the AMA's Government Affairs Manager. His name is Lucas Rodden. He confirmed what the FAA said – that Palomar RC Flyers was exempt from Mode C Veil requirements. Eric asked Lucas to send an email, which Eric then shared with the Board.

7:00 – Eric Armstrong made a motion to approve inviting two turbine heli pilots to the Heli Fun Fly under the following conditions:

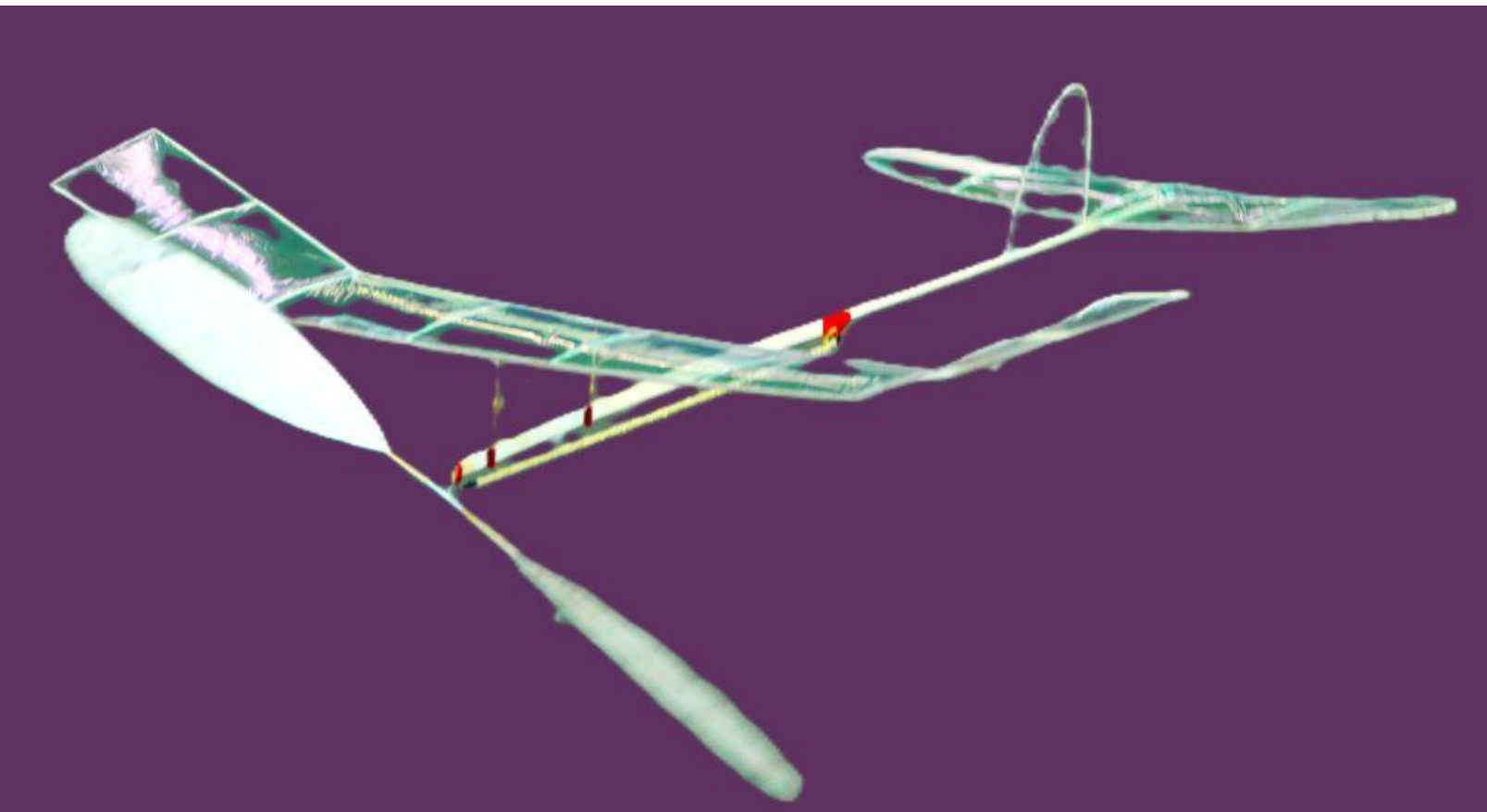
No additional turbine-heli pilots would be allowed to fly at Johnson Field other than the two for whom approval is being sought.

The turbine pilots must possess the necessary AMA waivers to fly rotary turbine aircraft.

Should a letter be produced from CalFire excluding turbine flying at Johnson Field, and the letter was deemed applicable to 2026, no heli turbine flying would be allowed.

Mark Olsen seconded the motion. Motion approved with 7 Yes votes, 1 No vote, and 1 No vote in absentia.

7:15 - Board meeting adjourned.

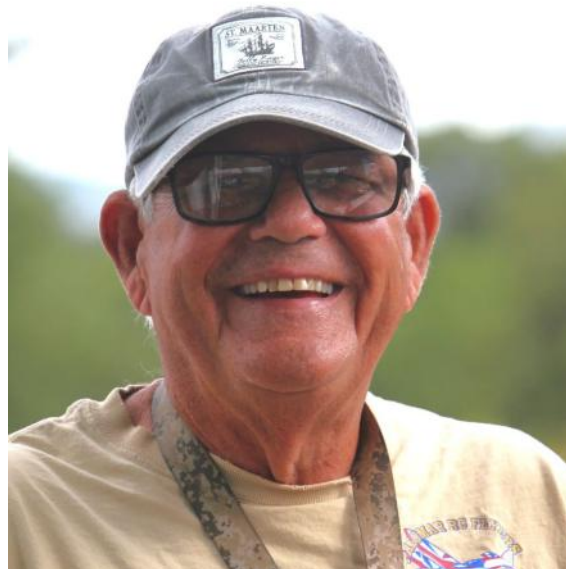

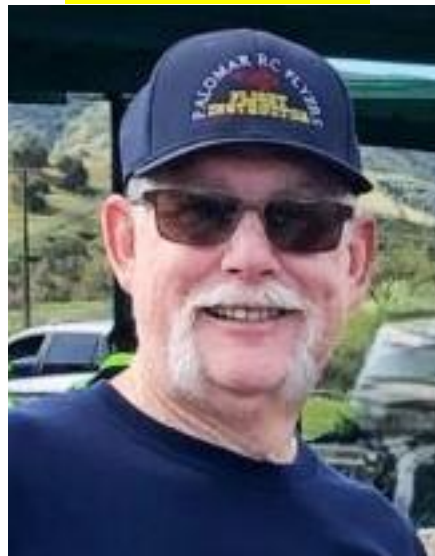
